This is regarding Compliance Report submitted by **Nirmala College of Pharmacy, Muvattupuzha P.O., Ernakulam Dist., Kerala- 686661** for the UG Pharmacy program which was accredited by NBA for academic years 2018-19 to 2020-21 and whose validity has expired on 30.06.2021.

2. National Board of Accreditation (NBA) has decided that in all cases of UG Pharmacy programs which were accredited for a period of 3 years from Academic Year 2018-19 to 2020-21 i.e. upto 30-06-2021 and for which the concerned Institutions have submitted Compliance Reports but their visits for data verification of the programs are pending because of the current pandemic situation due to Corona virus, the programs will be considered for accreditation of one year after data verification of the programs internally on the basis of the submitted Compliance Report.
