At the onset of each academic year, a comprehensive SWOC analysis is conducted to evaluate previous outcomes and synchronize them with institutional goals. The Academic Planning Committee takes charge of crafting an annual handbook, academic calendar, and extracurricular activities schedule ensuring a structured academic environment.

Curriculum planning is decentralized to departmental levels, ensuring alignment with predetermined outcomes in the adopted teaching methodologies. The college emphasis on interactive learning methods, continuous assessment, student participation in seminars, the timely completion of syllabi and examinations including monthly test assignments for students conducting on regular basis.

Moreover, integrates cross-cutting issues into its curriculum through professional events and programs, with the aim of sensitizing students to meet global concerns. Established in 2004 across a serene of 6-acre campus, The institution boasts 13 state-of-the-art ICT-enabled classrooms, including a smart classroom and an air-conditioned conference room. Security is paramount with CCTV surveillance ensuring safety across the campus. Additionally, the college offers a range of facilities including 20 laboratories, Wi-Fi connectivity, IT labs, and recreational amenities such as a gymnasium and cultural clubs. The laboratories are well-equipped, including an industrial unit that supports advanced pharmacological experiments. Administrative support is comprehensive, with facilities like placement offices, examination centers, and herbal garden contributing to a conducive learning environment. Separate hostels and a canteen cater to the residential needs of students, while power backup ensures uninterrupted learning.

The college library, operational from 9 am to 6 pm on working days, serves as a hub of knowledge with its vast collection of resources. Spanning 365 square meters, the library caters to its 650 members, offering books, journals, e-resources like J-Gate, CDs, and periodicals. Since January 2022, the library has adopted the Campus7 Integrated Library Management System, facilitating digital circulation and fine generation. Access to e-resources like DELNET and J-Gate enhances resource sharing and enables remote access for users. Moreover, the library provides access to various software and tools for language proficiency, drug design, statistical analysis, and clinical support, augmenting the academic experience of its users. The library sees an average of 65 users daily, with integrated open educational resources further enriching the learning ecosystem. College also have guest rooms.

The college witnessed notable improvements include projectors, computers, sound systems, and security measures such as CCTV surveillance and mobile phone jammers. Integration of advanced technology like Smart Classrooms, digital evaluation centers, and high-speed internet connections has significantly enriched the learning experience and streamlined administrative processes. Cloud-based services for library resources, exam papers, and campus management have enhanced operational efficiency, while biometric access control ensures stringent security measures. Leveraging digital platforms, including the college website and social media channels, has facilitated effective communication and engagement with stakeholders.
